RE: June-July Updates

Updates and Activities:

- NLTRA Placer County Contract approved June 26th by Board of Supervisors with minor wording changes in the dispute resolution clause. Changes were approved by Chair and Vice Chair.
- SV-AM Micro Mass Transit TBID Attended the Board of Supervisors meeting today. They voted unanimously to move this forward. Presented the positive comments and concerns raised by the Board. See attached information including the formation timeline.
- Capital Projects Advisory Committee Committee reviewed 29 projects submitted with total requests of \$35 million. The available balance of County TOT funds is \$5.8 million. The Committee voted to recommend \$4.997 million of TOT funding for 18 separate projects to the Board of Supervisors. Next meeting is July 26 to consider allocations of the remaining \$800K toward some or all of 8 other projects. These projects' total initial request was \$1.6 million but each organization has been asked to consider reducing their request. See attached. TOT Ordinance Update Placer County will be holding meetings on August 20th to discuss proposed TOT Ordinance changes. They have requested our participation in outreach to lodging partners.
- Working with the Ritz Carlton to coordinate a live broadcast by Peter Greenberg World Wide Radio on our destination, this Thursday, July 12. Authorized \$5,500 of Marketing Coop funding for the broadcast costs. See attached contract.
- Interviewed by Moonshine Ink on litigation on Tahoe City Lodge project. Given the litigation involves two of our Board members, I was careful to provide background from my previous position and comments in general on litigation impacts to future development.
- Reviewed three proposals and selected Sandbox Design to develop new website for NLTRA.org. Working with staff on discovery and design.
- Working with consultant and legal counsel on new employee manual.
- Attended Federal Reserve Bank of SF's presentation on Investing in Adaptation seminar.
- Working with staff on annual report.
- · Completing reviews for all employees.

The SV AM MMTD is designed to provide specific benefits directly to payors by diminishing the negative effects of high vehicle traffic on area roads and parking lots. The micro mass transit program will transport assessed businesses' guests, employees, and owners to high traffic hubs throughout the region to improve traffic conditions, the guests' experience, and safety.

Duration:

The proposed SV|AM MMTD will have a five (5) year life, beginning October 1, 2018 through September 30, 2023. Once per year, beginning on the anniversary of SV AM MMTD formation, there is a thirty (30) day period in which lodging business operators and ski resort businesses paying fifty percent (50%) or more of the assessment may protest and initiate a Board of Supervisors hearing on SV AM MMTD termination.

Collection:

The County will be responsible for collecting the assessment on a monthly or quarterly basis (including any delinquencies, penalties and interest) from each lodging business operator and ski resort business located in the boundaries of the SVIAM MMTD. The County shall take all reasonable efforts to collect the assessments from each lodging business operator and ski resort business.

Management: The Squaw | Alpine Transit Company (SATCo) will serve as the SV | AM MMTD's Owners' Association. The Owners' Association is charged with managing funds and implementing programs in accordance with this Plan, and must provide annual reports to the Board of Supervisors.

Protest:

Any owner of a lodging or ski resort business within the proposed SV/AM MMTD that will be subject to the assessment may protest the establishment of the SV/AM MMTD. If written protests are received from the owners of lodging or ski resort businesses in the proposed SVIAM MMTD who represent fifty percent (50%) or more of the estimated annual assessments to be levied, the SV AM MMTD shall not be established and the assessment shall not be imposed.

Season passes will not be subject to the assessment.

Budget:

The total SV|AM MMTD annual assessment budget for the initial year of its five (5) year operation is anticipated to be approximately \$715,000. This budget is expected to fluctuate as room and lift ticket sales do, but is not expected to significantly change over the SV|AM MMTD's term. I. OVERVIEW

Developed by Squaw Valley and Alpine Meadows lodging and ski resort businesses, the Squaw Valley | Alpine Meadows Micro Mass Transit District (SV | AM MMTD or District) is an assessment district proposed to provide specific benefits to payors, by funding a micro mass transit service for assessed lodging and ski resort businesses.

Location:

The proposed SV | AM MMTD includes all lodging and ski resort businesses located within the boundaries of Squaw Valley and Alpine Meadows in unincorporated Placer County (County), as shown on the map in Section III.

Services:

The SV | AM MMTD is designed to provide specific benefits directly to payors by diminishing the negative effects of high vehicle traffic on area roads and parking lots. The micro mass transit program will transport assessed businesses' customers, guests, employees, and owners to high traffic hubs throughout the region to improve traffic conditions, the guests' experience, and safety.

Budget:

The total SV | AM MMTD annual assessment budget for the initial year of its five (5) year operation is anticipated to be approximately \$715,000. This budget is expected to fluctuate as room and lift ticket sales do, but is not expected to significantly change over the SV | AM MMTD's term. In addition, stakeholders may request additional funding from Placer County to be able to provide more effective and robust service.

Lodging Businesses:

The annual lodging business assessment rate is one percent (1%) of gross short-term room rental revenue. 

The Owners' Association is committed to coordinating and connecting SV AM MMTD transit service with Placer County's Tahoe Truckee Area Regional Transit service, and maintaining regular communication with regional stakeholders, including the Truckee North Tahoe Transportation Management Association and the North Lake Tahoe Resort Association and will consider disestablishing the SV AM MMTD or combining the SV AM MMTD and its resources with a comprehensive district or regional transit service system in the future.
