Grant Priorities

The Tourism Master Plan grant program focuses on visitor-serving capital projects identified in three focus areas of the TMP including Visitor Activities and Facilities, Transportation and Visitor Information.

Example projects include:

- o Trails
- Wayfinding and interpretive signage
- Pedestrian infrastructure
- Facilities such as museums, interpretive centers, and public art

- 13 member CAP Committee co-chaired by Placer County and the Resort Association
- Application packet released in early February
- Proposals due late March
- Application updated per CAP feedback
- Application includes budget worksheet and schedule
- Proposals reviewed and ranked by CAP Committee per scoring criteria
- Recommendation presented to the BOS for approval

FY 2018-19 Grant Schedule

Grant Review/Approval Schedule

- o Proposal Deadline: April 4, 2019
- Review of chair and vice-chair recommendation: April 25, 2019
- Interviews: Thursday, May 30, 2019
- Committee deliberation: Special meeting on June 5
- Recommendation to BOS in late June and/or July
- Grant agreements developed after BOS approval



Grant Requirements

- Project addresses a priority in the Tourism Master Plan
- Projects must strengthen overall tourism economy
- Enhance visitor experience and economic value in eastern Placer County
- Quantifiable goals and objectives
- Measurable economic return on investment





- Ten percent match minimum
- Letter of support from land owner
- Letters of support from community organizations
- Complete application including required attachments (budget worksheet, letter of support, other)
- Minimum points in all six categories of the ranking sheet
- Minimum points for Tourism Master Plan category









- Revisions approved by the BOS on January 29, 2019
- Changes included addition of economic benefit category
- Additional points for projects that have previously received Transient Occupancy Tax funds and satisfied all grant requirements
- Additional points for projects identified in other community plans (Tahoe Basin, Area Plan, TART Systems Plan Update, other)
- o Emphasis on project proposals with new and innovative approaches to addressing community scounty north lake tahoe

Additional Items Added

- Proof of nonprofit status must be provided
- Fiscal sponsor required for groups without 501(c)3 or other legal designation
- Request detail on previous TOT awards:
 - Project status
 - Total of remaining funds
 - Timeline
- Limited budget for indirect costs
- Project timing
